Annual Report

July 1, 2014 – June 30, 2015

I. Description of School Facilities Improvement District No. 3 (Lemoore Area):

In the November 4, 2008 general election, the West Hills Community College District (WHCCD) succeeded in obtaining authorization from the Lemoore area's voters to issue \$31,000,000 in general obligation bonds. The School Facilities Improvement District No. 3 (Lemoore Area) (SFID-3 SFID-3/ Measure E) was a facilities and equipment bond measure on the ballot. Proceeds from the sale of the bonds were to be used for financing the long-term construction and facilities improvement projects at West Hills College Lemoore (WHCL).

In the November 6, 2012 general election, the West Hills Community College District (WHCCD) succeeded in obtaining a re-authorization from the Lemoore area's voters to issue the remaining balance of the \$31,000,000 in general obligation bonds, which had not previously been issued in the amount of \$12,656,255.00. The School Facilities Improvement District No. 3 (Lemoore Area) (SFID-3/ Measure L) was a facilities and equipment bond measure on the ballot. Proceeds from the sale of the bonds were to be used for financing the long-term construction and facilities improvement projects at West Hills College Lemoore (WHCL).

II. Citizens' Bond Oversight Committee:

The Committee does not make decisions regarding the use of SFID-3/ Measure E funds, but it does inform the public of bond revenue expenditures. To carry out its stated purpose, the following duties are set forth in the Committee Charter:

Inform the public concerning information regarding the WHCCD's expenditures of revenues received from the sale of SFID-3/ Measure E approved bonds.

Review expenditures to ensure that the bond proceeds are expended only for purposes set forth in the ballot.

Ensure that no bond proceeds are used for teacher or administrative salaries or other operating expenses.

The Committee shall present to the WHCCD Board of Trustees an Annual Report in written format which shall include a statement indicating whether the WHCCD is in compliance with the requirements of Article XIII A, Section 1(b) 3 of the California Constitution; and a summary of the Committee's proceedings and activities of the preceding fiscal year.

III. Meetings:

The Committee held its annual organizational meeting on January 27, 2016. At the meeting the following issues were also discussed:

- Measure E website presentation
- WHCCD Audit Report Review
- Annual Review of By-Laws
- SFID No. 3/ Measure E Annual Report (Draft)
- Measure E budget revisions
- Completion Recap/ project updates and expenditures
- Program and Audit Binder review
- Committee Member and Terms

The Committee has met every four months at the West Hills College Lemoore (WHCL) Golden Eagle conference room. Project updates are provided at each meeting along with financial reports by WHCCD staff and performance presentations from WHCCD consultants on topics of project planning, execution and completion. Agendas are developed from Committee member requests for data and staff input.

The 2016 meeting dates are scheduled to be:

January 27, 2016

May 4, 2016.

All agendas and minutes are posted at the WCHL office bulletin board and also on the Measure E website (www.measure-e.org). Meetings are held in accordance with the Ralph M. Brown Act (Open Meeting Laws).

IV. Activities of the Committee:

The following are activities that the Committee regularly participates in:

Approval of minutes from prior Committee meetings;

The Committee reviews budget, construction project analysis reports and reconciliation for SFID-3/ Measure E revenues and expenditures as presented by Mr. Kevin Cobb, Principal Architect or Mr. Richard Treece, Planner for AP Architects;

The financial reports for SFID-3/ Measure E revenues are provided by Mr. Ken Stoppenbrink, Deputy Chancellor Business/ Human Resources WHCCD;

The Committee takes periodic tours of the construction projects. In this manner, they are able to see what the details as to what has been reported upon. Any questions or concerns can be discussed on the sites so that a full understanding of all projects is achieved;

Any changes in the status or budgets of the projects are discussed openly and fully to the satisfaction of the Committee.

V. Establishment of Committee Member Terms:

Establishment of terms for Committee Members as well as voting for continuation of membership or replacement of members due to expiration of term or resignation of members is the duty of the WHCCD Board of Trustees.

All original Committee Members drew lots to determine the initial terms of their membership; lots were for one (1) or two (2) year assignments. The Committee Bylaws currently state that all members may serve a maximum of three consecutive terms.

VII. Audit:

As dictated by state law, the SFID-3/ Measure E bond requires a financial and performance audit which examines the usage of the bond funds. The firm of Vavrinek, Trine, Day & Company, LLP audited the SFID-3/ Measure E bond program for the fiscal year 2014/ 2015 ending June 30, 2015.

The audit report fiscal year 2014/ 2015 was presented to the Committee during their January 27, 2016 meeting and the audit was supportive of the program and its management.

The auditor's report gave an unqualified opinion that the financial statements fairly presented, in all material respects, the financial position and changes of the SFID-3 bond fund in conformity with accounting principles and generally accepted accounting standards.

In regards to the performance audit, the auditor's report noted no instances of noncompliance with the terms of Prop 39 for SFID-3/ Measure E. Nothing examined came to auditor's attention to indicate that WHCCD did not implement appropriate management controls to ensure the bond proceeds are administered economically, efficiently and effectively.

VIII. Statement of Compliance:

Based on the information provided by WHCCD, the Committee finds that as of this reporting for SFID-3/ Measure E from July 1, 2014 to June 30, 2015, that WHCCD is in compliance with the standards of Article XIII A Section 1(b) 3 of the California State Constitution and the terms of the original bond ballot.
